\*You do not have to set up on Friday. If you choose to set up on Friday night all items must be repacked overnight or you are responsible. There will be no security. If you choose not to set up on Friday your space will still be reserved for Saturday.

Exhibitors will be notified of acceptance by mail or telephone along with booth assignment and area information.

- 1.The Exhibitor expressly releases the Kershaw Hog Jam & Kershaw Chamber of Commerce from any and all liability for damage, injury or loss that may arise or occur to the Exhibitor, its employees, family or goods (or customers while in or about his booth) on the Premises during the duration of this contract.
- 2.The Kershaw Chamber of Commerce will provide no insurance for any reason except its own liability.
- 3.This show is Rain or Shine - No refunds will be given.
- 4.The road will be closed and you will be set up in front of the stores. Staking tents is not permitted.
- 5.The Exhibitor must supply his own tent, tables, displays, etc. None will be supplied.
- 6.Merchandise must be displayed in an appropriate manner. No aisles can be blocked. All items must have prices clearly marked. NO alcoholic beverages or controlled substances allowed on premises.
- 7.NO packing until after Festival closes at 10 PM on Friday and 6 PM on Saturday.
- 8.All State and Federal taxes are the responsibility of the Exhibitor.
- 9.No Political Signs can be displayed, except by the candidates themselves and only in their booths
10. No electricity or water is available- if using a generator let us know, it may affect placement
11. Your equipment must fit in your booth space if you need more room you will need to rent more than one booth

\*\*\* Food Vendors- DHEC will be onsite to check food. If you are unsure of the rules and regulations call and we will provide them. Also, REMEMBER there is no selling Barbeque!

You must list foods you plan on selling. We want all of our vendors to do well and do not allow too many of the same items. This is on a "first come" basis. You will be notified if there is an item that you can't sell.

Road will reopen at 7 PM on Saturday. If you need additional shut-down time please let us know.
